Super Simple Sausage & Vegetable Grill

- 1 small bag of the yellow golden potatoes
- 1 3lb bag of Normandy Vegetables
- 3 packages of Eckrich sausage. I use one package of regular, one package of jalapeno & cheddar and one package of 4 pepper.

Cube the potatoes (do not peel) and make a layer in the bottom of a large aluminum pan with a small amount of extra virgin olive oil, next add the vegetables, sprinkle with season salt (or if you want a little bit of spice, use Slap Ya Mama!), cut the sausage lengthwise and slice. Add to the top (this helps the juices from the sausage drip throughout the veggies and potatoes!) Cover with aluminum foil.

Cook on the grill on medium for 45 minutes to an hour. It can also be cooked in the oven but will take about two hours at 425 degrees. This makes a very large amount and can be scaled back to what you want!

Absolutely delicious!!
