### I. FINANCIAL REPORT:

A. **Release of Lien** – discussion held on filing a release of lien by mail rather than in person. Kim will call and ask if BOA has notary services, if so Andrea will take the lien release prepared by Kim to sign and be notarized Friday, 12/20/24 at the bank when she signs to add her name to the HOA accounts and then mail the release. Helen will call the Tulsa County Court Clerk's office to find out if we can mail in a release of lien with payment for the release fee and what the process is.

A. The Board voted unanimously in favor of having Kim order some heavy duty **removable** double-sided tape for 3M hooks to hang wreaths, from Amazon using the HOA debit card.

Southside walking trail** Kyle met with Denny from D&S Paving Dec. 6<sup>th</sup> to get opinion on the job that was done, Denny is to provide his opinion in writing and an estimate to make corrections/improvements to the path that was laid. Kim to reach out to Denny again for this in writing. The 2<sup>nd</sup> contractor that had an appt to come inspect declined to come after speaking with Kyle 12/06/24.
- iii. Painting Exterior Fence Pillars/Entrance Signs: Work continues, weather permitting.
- iv. Christmas Wreaths the wreaths were too heavy for the adhesive that came with the 3M hooks, the Board voted unanimously for Kim to look for a heavy duty removeable double-sided tape on Amazon and order on the HOA Debit card to hang the wreaths with.
- v. Christmas Garland the mounts ordered to hang the garland turned out to be to small to hold the weight of the garland. Kim will return the mounts to Amazon for HOA Debit card credit.

## **NEW BUSINESS**:

A. TruGreen – Kim suggested we ask TruGreen for a contract quote of 4 applications rather than 5 so we don't overextend ourselves with the budget, we can always add more treatments later on if funds are available. The Board was agreeable.
